Late entries or entries without payment will not be accepted.

Entry Requirements

- Entry is open to all foreign and local players not suspended or banned by SSRA, and/or ASF/WSF.
- All players will be required to have a valid WSF Spin to be able to play the tournament.
- All participants must have a WSF SPIN. You may register for a WSF SPIN (fee involved) at <https://www.worldsquash.sport/spins/>. Entries without SPIN will be rejected.

Nationals/ASF/WSF Ranking (whichever is applicable)

All participants are advised to include their national/ASF/WSF ranking in their entry forms. This would facilitate us in preparing the draws for the tournament.

Withdrawal

- Any withdrawal(s) must notify ignitesquash.event@gmail.com immediately with valid reason. Entry fees **WILL NOT BE REFUNDED** if withdrawal is done after the closing date.
- Paid up entry fee is non-transferable between participants.
- Late withdrawal.** Withdrawal after the closing date will be considered 'late withdrawal'. All late withdrawals must be accompanied by a Medical Certificate (MC) or any official documentation, subject to the approval of the Organiser. Failing to do so will result in the participant scoring 'ZERO' AJSS ranking points which will be reflected as one of the participant's best 4 results. For those who produce the MC or official documentation, ASF will evaluate each withdrawal on a case-by- case basis. Entry fee is still payable for all LATE WITHDRAWALS.

Match Format And Scoring

- Tournament format will be determined by the organiser depending on the draw size. Organiser guarantees a minimum of 2 matches per participant.
- Main Draw match is competing in best of 5 games, 11 points – PAR (Point-A-Rally) and following the WSF Singles Rules 2025. All Plate Event matches will be decided after the closing date, subjected to available resources.

Marking And Refereeing

- All players participating in the tournament are required to take on marking and refereeing duties as assigned by the organizers. It is the responsibility of each player to fulfil these roles when allocated, ensuring the smooth running of matches and adherence to tournament regulations.
- The Tournament Referee maintains the authority to change or reassign referees on any court at their discretion. This measure ensures fairness, proper conduct, and the efficient management of matches throughout the event.

Players On Court

- It is the responsibility of each player/team to be ready to play at the designated start time of the match. Check-in One (1) hour before scheduled match time. Match timing is an indication only.
- Matches will be played on a FOLLOW-ON-BASIS. Postponement of match will not be entertained.

- A walkover will be awarded against participants who are more than 15minutes late upon being called to start the match; subsequent matches will be forfeited; no points and rankings will be awarded unless a valid MC is produced and notice is given to the organiser prior to the start of the match.

Official Ball and Eyewear

- Dunlop Double Yellow Dot Balls will be used during the Tournament.
- WSF Certified Eyewear is mandatory for all participants.

Tin Height

In accordance with WSF rules and regulations, the height shall be 19 inches.

Practice Courts

- Practice/test courts are free of charge and are available for all players and teams on 10th February 2026 starting from 9:00 to 17:00 hours only.
- Allocation is on a first come first serve basis. The organiser has the right to alter and limit the allocated times at any time to ensure that everyone can practice. Please book considerably.

Medical

Medical personnel will be present on site throughout all sessions of play. In the case of medical emergencies and/or accidents, please report to the Tournament Office for assistance and necessary action.

Tournament T-shirt

All participants will receive a tournament T-shirt.

Personal Belongings

Players are responsible for the security of their own belongings while at the venue. Please do not leave bags or personal items (including squash bags) unattended at any time. Ignite Squash will not be held responsible for any lost or misplaced items.

Prizes and Medals

- Prize presentation will be held on 14th February 2026 (Saturday) immediately after the BU19 final.
- All participants are expected to be at the venue wearing the official tournament T-Shirt and covered shoes. Sandals and slippers are **NOT ALLOWED**.
- All prizes will be forfeited if winners are not present to collect them in person.
- Prizes in kind and medals will be awarded to all **Top 4** in all categories.
- Medals for 5th - 8th will only be available if there is minimum draw size of 16 people.
